FAILURE OF THE CHAIN RULE FOR THE DIVERGENCE OF BOUNDED VECTOR FIELDS

ABSTRACT. We provide a vast class of counterexamples to the chain rule for the divergence of bounded vector fields in three space dimensions. Our convex integration approach allows us to produce renormalization defects of various kinds, which in a sense quantify the breakdown of the chain rule. For instance, we can construct defects which are absolutely continuous with respect to the Lebesgue measure, or defects which are not even measures.

1. Introduction

In this paper we consider the classical problem of the chain rule for the divergence of a bounded vector field. Specifically, the problem can be stated in the following way:

Let $\Omega \subset \mathbb{R}^d$ be a domain with Lipschitz boundary. Given a bounded vector field $v: \Omega \to \mathbb{R}^d$ tangent to the boundary and a bounded scalar function $\rho: \Omega \to \mathbb{R}$, one asks whether it is possible to express the quantity $\operatorname{div}(\beta(\rho)v)$, where β is a smooth scalar function, only in terms of β , ρ and the quantities $\mu = \operatorname{div} v$ and $\lambda = \operatorname{div}(\rho v)$.

Indeed, formally we should have that

$$\operatorname{div}(\beta(\rho)\nu) = (\beta(\rho) - \rho\beta'(\rho))\mu + \beta'(\rho)\lambda. \tag{1.1}$$

However, the extension of (1.1) to a nonsmooth setting is far from trivial. The chain rule problem is particularly important in view of its applications to the uniqueness and compactness of transport and continuity equations, whose analysis is nowadays a fundamental tool in the study of various equations arising in mathematical physics. Indeed continuity equations arise naturally for instance in compressible fluid mechanics in order to model the evolution of the density of a fluid. Renormalization and uniqueness for the Cauchy problem have been proved in [DL89] and [Amb04], respectively for Sobolev vector fields and for vector fields of bounded variation. See also the survey [AC14] for a detailed review of results in this direction.

The chain rule problem for nonsmooth vector fields has been considered in several papers, in particular in [ADLM07]. There, it is proved that if v is of bounded variation and $\operatorname{div}(\rho v)$ is a measure, then $\operatorname{div}(\beta(\rho)v)$ is also a measure and in particular formula (1.1) holds for the absolutely continuous parts of λ and μ . The singular part is partially characterized in the cited article.

In this paper, we prove that in the three dimensional case for vector fields which are merely bounded the formula (1.1) is invalid in a very strong sense. Specifically, for a strongly convex function $\beta:(0,\infty)\to\mathbb{R}$ and a given **renormalization defect** $f:\Omega\to\mathbb{R}$ we construct a divergence-free vector field v and a scalar function ρ satisfying

$$div(\rho v) = 0 \text{ in } \Omega$$

$$div(v) = 0 \text{ in } \Omega$$

$$v \cdot n = 0 \text{ on } \partial \Omega$$
(1.2)

such that

$$\operatorname{div}(\boldsymbol{\beta}(\boldsymbol{\rho})\boldsymbol{v}) = f. \tag{1.3}$$

More precisely, our main theorem reads as follows:

Theorem 1.1. Let d=3 and let $\Omega \subset \mathbb{R}^d$ be a (not necessarily bounded) domain with Lipschitz boundary and $\beta:(0,\infty)\to\mathbb{R}$ be strongly convex. Let moreover f be a distribution such that the equation

$$\operatorname{div} w = f$$

admits a bounded continuous solution on Ω . Then there exist $v \in L^{\infty}(\Omega; \mathbb{R}^d)$ and $\rho \in L^{\infty}(\Omega; \mathbb{R})$ such that |v| and ρ are positive and bounded away from zero almost everywhere, and such that (1.2) and (1.3) are satisfied in the sense of distributions.

Remark 1.2. Theorem 1.1 is still valid for $d \ge 3$, with essentially the same proof.

Remark 1.3. Theorem 1.1 does not hold for d=2. Namely, from the results established in [BG] (see Theorem 7.1) it follows that, if $v \in L^{\infty}(\Omega; \mathbb{R}^2)$ and $\rho \in L^{\infty}(\Omega; \mathbb{R})$ satisfy $\operatorname{div} v = 0$, $\operatorname{div}(\rho v) = 0$, and ρ is positive and bounded away from zero almost everywhere, then the equation

$$\operatorname{div}(\beta(\rho)v) = 0$$

holds for any $\beta \in C^1(\mathbb{R})$. Thus (1.3) holds only with f = 0. In view of this and of the previous remark our result can be interpreted as complementary to the ones in [BG].

Remark 1.4. The requirement on f in Theorem 1.1 is satisfied for instance when Ω is bounded and $f \in L^p(\Omega)$ with p > d. However, there exist also distributions f which are not measures for which the divergence equation admits a bounded continuous solution. In particular, our result shows that if we drop the BV regularity assumption on the vector field v, then the quantity $\operatorname{div}(\beta(\rho)v)$ can fail to be a measure, even though λ and μ vanish.

As mentioned above, the chain rule is strongly connected with the uniqueness for the Cauchy problem for transport and continuity equations. Several counterexamples to the uniqueness of continuity equations in a nonsmooth setting are known, see [Aiz78, CLR03, Dep03, ABC14, ABC13] and also [CGSW15], where a similar approach based on convex integration is used. Some of these examples can be modified in order to obtain counterexamples to the chain rule with vector fields more regular than L^{∞} . More specifically, the example in [Dep03] can be modified to obtain a divergence-free vector field with locally bounded variation out of a hyperplane in \mathbb{R}^3 (the BV norm however blows up when approaching such a hyperplane), while the example in [ABC14, ABC13] can be modified to obtain a divergence-free vector field in all Hölder classes C^{α} , with $\alpha < 1$. Further counterexamples to renormalization have recently come from the direction of active scalar equations, where a transport equation is coupled with a nonlocal relation between the velocity and the density. In these examples [CFG11, Szé12, Shv11, IV], obtained by convex integration methods, the non-renormalization is obtained as a byproduct of the analysis. In [BLFNL15] the authors deal with a passive tracer. However, all the examples mentioned yield only very specific renormalization defects. In particular, diffuse defects and defects which are not measures have not been known previously.

We close this introduction with a short comment on our method. We also use a convex integration scheme, but in order to control the renormalization defect, we need to use perturbations obtained from laminates, thus taking an approach reminiscent of [MŠ03, AFS08, CS14, KRW15,

KRW]. Our convergence strategy relies on Young measures (cf. [KRW15, KRW]) and avoids the Baire category method, thus giving a somewhat explicit construction. The core of our proof is a study (in Section 5 below) of the geometry of the nonlinear constraint sets K_C (see (3.2)) in matrix space. It is at this point that the specific properties of our problem enter. Note that in dimension 2 our rank-2 condition would turn into a rank-1 condition, which would be too rigid for the geometric constructions of Section 5 (compare with Remark 1.3).

2. Preliminaries

A function $\beta:(0,\infty)\to\mathbb{R}$ is called **strongly convex** if there exists $\kappa>0$ such that, for all $x_1,x_2>0$ and $0\leq\lambda\leq1$,

$$\beta(\lambda x_1 + (1 - \lambda)x_2) \le \lambda \beta(x_1) + (1 - \lambda)\beta(x_2) - \kappa \lambda (1 - \lambda)|x_1 - x_2|^2. \tag{2.1}$$

For instance, the map $x \mapsto x^2$ is strongly convex with $\kappa = 1$. We remark in passing that for the purposes of this paper, we could replace $|x_1 - x_2|^2$ by $\varphi(|x_1 - x_2|)$, where $\varphi : [0, \infty) \to [0, \infty)$ is an increasing function with $\varphi(0) = 0$ and $\lim_{t \to \infty} \varphi(t) = \infty$.

Proposition 2.1. *If* β : $(0, \infty)$ *is strongly convex for a* $\kappa > 0$ *, and if* $\lambda < 0$ *and* $x_1, x_2 > 0$ *are such that* $\lambda x_1 + (1 - \lambda)x_2 > 0$ *, then*

$$\lambda \beta(x_1) + (1 - \lambda)\beta(x_2) \le \beta(\lambda x_1 + (1 - \lambda)x_2) + \kappa \lambda(1 - \lambda)|x_1 - x_2|^2$$
.

Proof. This follows by replacing x_1 by $\lambda x_1 + (1 - \lambda)x_2$, x_2 by x_1 , and λ by $1/(1 - \lambda)$ in (2.1). \square

Remark 2.2. An immediate remark is that for the proof of Theorem 1.1 we may assume, without loss of generality, that $\beta(1) = 1$. Indeed, by (1.2), equation (1.3) remains unaffected by adding a constant to β . We will make this assumption throughout the rest of the paper.

We recall the space of solenoidal vectorfields on Ω (cf. Chapter III of [Gal94]),

$$H(\Omega) = \left\{ v \in L^2(\Omega; \mathbb{R}^3) : \int_{\Omega} v \cdot \nabla p dx = 0 \text{ for every } p \in W^{1,2}(\Omega) \right\}.$$

It is known that if $(v_n) \subset C^1(\bar{\Omega}; \mathbb{R}^3)$ is a sequence of divergence-free vector fields such that v(x) = 0 on $\partial \Omega$, and if the sequence converges weakly in $L^2(\Omega)$ to a field v, then $v \in H(\Omega)$.

The problem (1.2), (1.3) can then be formulated in the sense of distributions in the following way: Find $v \in H(\Omega)$ such that for every $\psi \in C_c^{\infty}(\Omega)$, we have

$$\int_{\Omega} \rho v \cdot \nabla \psi dx = 0$$

and

$$\int_{\Omega} \beta(\rho) v \cdot \nabla \psi dx + \int_{\Omega} f \psi dx = 0$$

(if f is merely a distribution, the second integral is of course to be understood as the action of f on ψ).

In our iteration scheme, the perturbations will be chosen as members of **recovery sequences** of **rank-2 laminates**. These are defined as follows (cf. [Dac85] and also Definition 9.1 in [Ped97] for the rank-1 analogue):

Definition 2.3. a) Suppose $\lambda_i > 0$ for i = 1, ..., n, $\sum_{i=1}^n \lambda_i = 1$, and $U_i \in \mathbb{R}^{3\times 3}$ for i = 1, ..., n. The family of pairs $(\lambda_i, U_i)_{i=1}^n$ satisfies the (inductively defined) H_n -condition if

- i) $rank(U_2 U_1) \le 2$ in the case n = 2;
- ii) after a relabeling of indices, if necessary, we have $\operatorname{rank}(U_2 U_1) \leq 2$ and the family $(\tau_i, V_i)_{i=1}^{n-1}$ satisfies the H_{n-1} -condition, where

$$\tau_1 = \lambda_1 + \lambda_2$$
, $\tau_i = \lambda_{i+1}$ for $i = 2, \dots, n-1$

and

$$V_1 = \frac{\lambda_1}{\tau_1}U_1 + \frac{\lambda_2}{\tau_1}U_2, \ \ V_i = U_{i+1} \ \ \text{for } i = 2, \dots, n-1$$

in the case n > 2.

Moreover we adopt the convention that every pair of the form (1,U) satisfies the H_1 condition.

b) A probability measure v on $\mathbb{R}^{3\times 3}$ is said to be a **rank-2 laminate** of order n if it has the form

$$v = \sum_{i=1}^n \lambda_i \delta_{U_i}$$

for a family $(\lambda_i, U_i)_{i=1}^n$ which satisfies the H_n -condition.

For the **expectation** of a probability measure, we write

$$\bar{\mathbf{v}} := \int_{\mathbb{D}^{3\times 3}} V d\mathbf{v}(V).$$

A parametrized probability measure or Young measure is a map $\Omega \ni x \mapsto v_x$, where v_x is a probability measure on $\mathbb{R}^{3\times 3}$. It is said to be **weakly* measurable** if the map

$$x \mapsto \int_{\mathbb{R}^{3\times 3}} h(z) d\mathbf{v}_x(z)$$

is measurable in the usual sense for every bounded continuous test function $h: \mathbb{R}^{3\times 3} \to \mathbb{R}$.

We also need to define the **rank-2 lamination convex hull** of a set $K \subset \mathbb{R}^{3\times 3}$. A similar notion for rank-1 laminates is presented e.g. in Section 4.4 of [Mül99].

Definition 2.4. Let $K \subset \mathbb{R}^{3\times 3}$. A matrix $U \in \mathbb{R}^{3\times 3}$ is contained in the **rank-2 lamination convex** hull of K, denoted K^{2lc} , if and only if

$$U = \sum_{i=1}^{n} \lambda_i U_i$$

for a family $(\lambda_i, U_i)_{i=1}^n$ that satisfies the H_n -condition and such that $U_i \in K$ for every i = 1, ..., n.

3. Proof of Theorem 1.1

Step 1: Reformulation of the problem. First we rewrite equations (1.2) and (1.3) as the conjunction of an underdetermined *linear* differential system and a nonlinear *pointwise* constraint, thus adopting a viewpoint similar to the one in [DLS09].

Let us therefore consider the linear system of equations

$$div(m) = 0$$

$$div(v) = 0$$

$$div(w) = f$$
(3.1)

in the unknowns $(m, v, w) : \Omega \to \mathbb{R}^{3 \times 3}$. We also define the constraint set, with given constant C > 1, as

$$K_C := \left\{ (m, v, w) \in \mathbb{R}^{3 \times 3} : \frac{1}{C} \le |v| \le C \right.$$
and there is $\frac{1}{C} \le \rho \le C$ such that $m = \rho v, w = \beta(\rho)v \right\}.$

$$(3.2)$$

Thus K_C is a non-empty compact subset of $\mathbb{R}^{3\times 3}$. Then, clearly, if a triplet of measurable maps (m, v, w) satisfies (3.1) in the sense of distributions, if $(m, v, w)(x) \in K_C$ for almost every $x \in \Omega$, and if $v \in H(\Omega)$, then v and $\rho(x) := |m(x)|/|v(x)|$ will be a solution of (1.2) and (1.3) as in Theorem 1.1.

Step 2: Recovery of rank-2 laminates. It is convenient to identify a triplet (m, v, w) with the matrix U whose rows are given by m, v and w. Equations (3.1) then mean that

$$div(U) = (0, 0, f)^T, (3.3)$$

where the divergence is taken row-wise as usual.

An important building block for our construction is the fact that rank-2 laminates can be approximated in an appropriate sense by solutions of (3.3). This is the content of the following lemma, whose proof is largely standard (c.f. e.g. Proposition 9.2 in [Ped97] or Proposition 19 in [SW12] for similar constructions). We give the full proof for the reader's convenience, but postpone it to Section 4.

Lemma 3.1. Let $K \subset \mathbb{R}^{3\times 3}$ be compact and $(v_x)_{x\in\Omega}$ be a weakly*-measurable family of probability measures such that

- a) the measure v_x is a rank-2 laminate of finite order for almost every $x \in \Omega$,
- b) supp $v_x \subset K$ for almost every x.

Assume further that $\psi \in C(\mathbb{R}^{3\times 3};\mathbb{R})$ is a non-negative function that vanishes on K. Then the expectation \bar{v}_x is well-defined for almost every $x \in \Omega$ and for every $\varepsilon > 0$ there exists a matrix-valued function U such that

i) $\operatorname{div} U = \operatorname{div} \bar{\mathbf{v}}$ in the sense of distributions,

ii)

$$\int_{\Omega} \psi(U(x)) dx < \varepsilon,$$

iii)

$$\|\operatorname{dist}(U(x),K^{2lc})\|_{L^{\infty}(\Omega)}<\varepsilon,$$

iv)

$$\int_{\Omega} |U(x) - \bar{\mathbf{v}}_x| \, dx < \int_{\Omega} \int_{\mathbb{R}^{3 \times 3}} |V - \bar{\mathbf{v}}_x| \, d\mathbf{v}_x(V) dx + \varepsilon. \tag{3.4}$$

Moreover, if $\bar{\mathbf{v}} \in C(\bar{\Omega})$, then U can be chosen to satisfy $U \in C(\bar{\Omega})$ and

$$U(x) = \bar{v}_x$$
 on $\partial \Omega$.

Step 3: Initial step of the iteration. Our iteration process will start with a triplet of the form (0,0,w), where $\operatorname{div}(w) = f$. Since our construction is in a sense local, we can "freeze" x and first consider a constant vector $w \in \mathbb{R}^3$. The goal is to decompose the matrix U corresponding to (0,0,w) along rank-2 lines as a sum of matrices in K_C (of course K_C can be viewed as a subset of the space of 3×3 -matrices). More precisely, we have

Lemma 3.2. Let $U \in \mathbb{R}^{3\times 3}$ such that $U^T e_1 = U^T e_2 = 0$ and $|U^T e_3| \ge 1$. Then there exists a rank-2 laminate $\mathbf{v} = \sum_{i=1}^n \lambda_i \delta_{U_i}$ such that

$$U = \sum_{i=1}^{n} \lambda_i U_i$$

and a number C > 1 such that

supp
$$\nu$$
 ⊂ K_C .

Moreover there exists a constant C_{β} depending only on β such that $C \leq \max\{C_{\beta}, 4|U^Te_3|\}$.

The proof will be given in Section 5.

Step 4: Subsequent steps of the iteration. The last lemma we need reads as follows:

Lemma 3.3. Let $\varepsilon > 0$ and $\tilde{C} > 1$. There exists a strictly increasing continuous function $h: [0,\infty) \to [0,\infty)$, depending only on \tilde{C} and β , with h(0) = 0, and a number $\delta > 0$, depending only on \tilde{C} , β , and ε , such that for every $1 < C < \tilde{C} - \varepsilon$ and every $U \in \mathbb{R}^{3\times 3}$ such that $\operatorname{dist}(U, K_C^{2lc}) < \delta$, there exists a rank-2 laminate $v = \sum_{i=1}^n \lambda_i \delta_{U_i}$ such that

$$U = \sum_{i=1}^{n} \lambda_i U_i, \tag{3.5}$$

$$\sum_{i=1}^{n} \lambda_i |U_i - U| \le h\left(\operatorname{dist}(U, K_C)\right),\tag{3.6}$$

and

supp
$$ν$$
 ⊂ $K_{C+ε}$.

The proof is postponed to Section 5.

Remark 3.4. If $x \mapsto U(x)$ is measurable and satisfies the assumptions of Lemma 3.2 or 3.3 for almost every x, respectively, then the laminates v_x obtained from the respective lemma form a weakly* measurable family, i.e. a Young measure.

Step 5: Conclusion. We are now ready to prove Theorem 1.1. Let f be as in the statement of the theorem. Our goal is to inductively define a sequence $(m_n, v_n, w_n)_{n\geq 0}$ of solutions to (3.1) that approaches the constraint set K_C in a suitable sense, for a suitable constants C > 1.

First we define the triplet (m_0, v_0, w_0) by setting $v_0 \equiv 0$, $m_0 \equiv 0$; w_0 is chosen as a bounded continuous solution of div w = f, which exists by assumption. Since the divergence is not affected by adding a constant, we may assume $|w_0(x)| \ge 1$ in $\bar{\Omega}$.

Next, let $C_0 > 1$ be as required by Lemma 3.2 applied to $U_0(x)$ for all $x \in \bar{\Omega}$ (this is possible since U_0 is bounded). Next, pick a sequence $(C_n)_{n \geq 0}$ that is strictly increasing such that $C_n \nearrow C_0 + 1 =: C$ as $n \to \infty$. We also set $\varepsilon_n := C_{n+1} - C_n$. Then, (ε_n) is a sequence of positive numbers converging to zero.

Identifying (m_0, v_0, w_0) with its corresponding matrix field U_0 , by Lemma 3.2 there exists for almost every $x \in \Omega$ a rank-2 laminate v_x^0 of finite order whose expectation is $U_0(x)$ and whose support is contained in K_{C_0} . This completes the definition of U_0 and v^0 .

Suppose now that U_n and v^n have already been constructed for some $n \ge 0$ in such a way that supp $v^n \subset K_{C_n}$ and (3.3), (3.5), (3.6) are satisfied, that is:

$$\operatorname{div}(U_n) = (0,0,f)^T,$$

$$U_{n}(x) = \bar{\mathbf{v}}_{x}^{n},$$

$$\int_{\mathbb{R}^{3\times 3}} |V - U_{n}(x)| d\mathbf{v}_{x}^{n}(V) \le h\left(\operatorname{dist}(U_{n}, K_{C_{n-1}})\right).$$
(3.7)

The last estimate is claimed only for $n \ge 1$. By Lemma 3.3, where we set $\varepsilon = \varepsilon_{n+1}$ and $\tilde{C} = C + 1$, there exists $\delta_{n+1} = \delta(\varepsilon_{n+1})$ such that whenever

$$\operatorname{dist}(U, K_{C_n}^{2lc}) < \delta_{n+1},$$

then there exists a rank-2 laminate whose expectation is U and whose support is contained in

$$K_{C_n+\varepsilon_{n+1}} \subset K_{C_{n+1}}.$$
 (3.8)

Therefore we apply Lemma 3.1 to (v_x^n) with K_{C_n} , $\varepsilon = \delta_{n+1}$, and

$$\psi = h\left(\operatorname{dist}(\bullet, K_{C_n})\right).$$

This yields a matrix field U_{n+1} satisfying

$$\operatorname{div}(U_{n+1}) = \operatorname{div}(\bar{\mathbf{v}}_{x}^{n}) = \operatorname{div}(U_{n}) = (0, 0, f)^{T},$$

$$\int_{\Omega} h\left(\operatorname{dist}(U_{n+1}(x), K_{C_n})\right) dx < \delta_{n+1},\tag{3.9}$$

and

$$\|\operatorname{dist}(U_{n+1}(x), K_{C_n}^{2lc})\|_{L^{\infty}(\Omega)} < \delta_{n+1}.$$
 (3.10)

Therefore, by (3.8), we can indeed find, for every x, a rank-2 laminate V_x^{n+1} with support in $K_{C_{n+1}}$ satisfying (3.5) and (3.6). This completes the construction of the sequence (U_n) .

Next, using (3.7), (3.4), (3.6), and (3.9), we obtain for $n \ge 1$

$$\int_{\Omega} |U_{n+1}(x) - U_n(x)| dx = \int_{\Omega} |U_{n+1}(x) - \bar{\mathbf{v}}_x^n| dx$$

$$\leq \int_{\Omega} \int_{\mathbb{R}^{3\times 3}} |V - \bar{\mathbf{v}}_x^n| d\mathbf{v}_x^n dx + \delta_{n+1}$$

$$\leq \int_{\Omega} h\left(\operatorname{dist}(U_n(x), K_{C_{n-1}})\right) dx + \delta_{n+1}$$

$$\leq \delta_n + \delta_{n+1}.$$
(3.11)

By (3.11) and since we may assume $\delta_n \leq \varepsilon_n$, the sequence (U_n) is Cauchy in $L^1(\Omega)$. Indeed, this follows from $\sum_{n=0}^{\infty} \varepsilon_n = C - C_0 = 1$. Therefore, (U_n) converges strongly in L^1 to a limit matrix field $U_{\infty} \in L^1(\Omega)$, and up to a subsequence (not relabeled) the convergence even takes place almost everywhere.

Finally, by (3.10) and the observation that $K_{C_n} \subset K_C$ for every n, the sequence (U_n) is bounded in L^{∞} , and by (3.9)

$$\int_{\Omega} h\left(\operatorname{dist}(U_{n+1}(x), K_{C})\right) dx \leq \int_{\Omega} h\left(\operatorname{dist}(U_{n+1}(x), K_{C_{n}})\right) dx \to 0$$

as $n \to \infty$. It follows then from dominated convergence that

$$\int_{\Omega} h\left(\operatorname{dist}(U_{\infty}(x), K_{C})\right) dx = 0,$$

so that $U_{\infty}(x) \in K_C$ for almost every $x \in \Omega$.

As a final observation, since $v_0 \equiv 0$ and the boundary values of $U_n^T e_2$ remain unchanged in passing from n to n+1 thanks to the last statement of Lemma 3.1, we may conclude $U_{\infty}^T e_2 \in H(\Omega)$. According to Step 1, U_{∞} thus gives rise to the desired solution.

4. RECOVERY SEQUENCES FOR RANK-2 LAMINATES

In this section we prove Lemma 3.1.

The approximating maps for parametrized measures, whose existece is claimed in the Lemma, will be composed of **localized plane waves** as in [DLS09], which satisfy the divergence-free condition

$$div(m) = 0$$

$$div(v) = 0$$

$$div(w) = 0.$$
(4.1)

A **plane wave solution** is a solution of (4.1) of the form $(\bar{m}, \bar{v}, \bar{w})h(x \cdot \xi)$, where $(\bar{m}, \bar{v}, \bar{w}) \in \mathbb{R}^{3 \times 3}$ is constant and $\xi \in \mathbb{R}^3 \setminus \{0\}$. The function $h : \mathbb{R} \to \mathbb{R}$ is called the **profile function**. The **wave cone** of (4.1) is then defined as

$$\Lambda := \left\{ (\bar{m}, \bar{v}, \bar{w}) \in \mathbb{R}^{3 \times 3} : \text{There exists } \xi \neq 0 \text{ such that} \right. \\ \left. (\bar{m}, \bar{v}, \bar{w}) h(x \cdot \xi) \text{ satisfies (4.1) for every smooth } h : \mathbb{R} \to \mathbb{R} \right\}.$$

The characterization of the wave cone is standard. To formulate it, it is convenient to identify a triplet (m, v, w) with the matrix U whose rows are given by m, v and w. Condition (4.1) then means that

$$\operatorname{div}(U) = 0, (4.2)$$

where the divergence is taken row-wise as usual.

Proposition 4.1. The wave cone for (4.2) is the set of all matrices $\bar{U} \in \mathbb{R}^{3\times 3}$ whose determinant is zero.

Proof. This follows immediately from the fact that
$$\operatorname{div}(\bar{U}h(x \cdot \xi)) = h'(x \cdot \xi)\bar{U}\xi$$
.

We are now ready to prove Lemma 3.1, which we recall for convenience:

Lemma. Let K be a compact subset of $\mathbb{R}^{3\times 3}$, and $(v_x)_{x\in\Omega}$ be a weakly*-measurable family of probability measures such that

- a) the measure V_x is a rank-2 laminate of finite order for almost every $x \in \Omega$,
- b) supp $v_x \subset K$ for almost every x.

Assume further that $\psi \in C(\mathbb{R}^{3\times 3};\mathbb{R})$ is a non-negative function that vanishes on K. Then, for every $\varepsilon > 0$ there exists a matrix-valued function U such that

i)
$$\operatorname{div} U(x) = \operatorname{div} \bar{\mathbf{v}}_x$$
 for almost every $x \in \Omega$,

ii)

$$\int_{\Omega} \psi(U(x)) dx < \varepsilon,$$

iii)

$$\|\operatorname{dist}(U(x),K^{2lc})\|_{L^{\infty}(\Omega)}<\varepsilon,$$

iv)

$$\int_{\Omega} |U(x) - \bar{v}_x| dx < \int_{\Omega} \int_{\mathbb{R}^{3\times 3}} |V - \bar{v}_x| dv_x(V) dx + \varepsilon. \tag{4.3}$$

Moreover, if $\bar{\mathbf{v}} \in C(\bar{\Omega})$, then U can be chosen to satisfy $U \in C(\bar{\Omega})$ and

$$U(x) = \bar{\mathbf{v}}_x$$
 on $\partial \Omega$.

Remark 4.2. In the situation of the Lemma, we say that U approximates the parametrized measure (v_x) with precision ε .

Proof. **Step 1.** Suppose first that we are dealing with a homogeneous measure with zero expectation, i.e. $x \mapsto v_x$ is constant almost everywhere and $\bar{v} = 0$. To start an inductive argument, consider first the case that v is a rank-2 laminate of order 2, i.e. $v = \lambda \delta_{U_1} + (1 - \lambda)\delta_{U_2}$ with rank $(U_2 - U_1) \le 2$ and $U_1, U_2 \in K$. Therefore, there exists a non-zero $\xi \in \mathbb{R}^3$ such that $(U_2 - U_1)\xi = 0$ and hence, by Proposition 4.1, the matrix field

$$U_n(x) = \lambda U_1 + (1 - \lambda)U_2 + h(nx \cdot \xi)(U_2 - U_1) = h(nx \cdot \xi)(U_2 - U_1)$$

is divergence-free for any frequency n and any profile h (the second equality follows from \bar{v} =0). We choose here as our profile the 1-periodic extension of the function

$$h(t) = \begin{cases} \lambda & \text{if } t \in [0, 1 - \lambda) \\ -(1 - \lambda) & \text{if } t \in [1 - \lambda, 1). \end{cases}$$

To achieve zero boundary values, we use a standard cutoff technique as follows: Since $div(U_n) = 0$, there exists another matrix field Φ_n such that

$$U_n = \operatorname{curl}(\Phi_n), \tag{4.4}$$

the curl being taken row-wise. Indeed, we can explicitly exhibit such a field: Let H be such that H' = h; since h has mean zero, H is bounded on all of \mathbb{R} . Let also V_i denote the i-th row of the matrix $U_2 - U_1$. Then, by choice of ξ , V_i is orthogonal to ξ for i = 1, 2, 3, and hence there exist vectors A_i such that $\xi \times A_i = V_i$. Then, we have

$$\operatorname{curl}\left(\frac{1}{n}H(nx\cdot\xi)A_i\right) = h(nx\cdot\xi)\xi \times A_i = h(nx\cdot\xi)V_i,$$

so that (4.4) is satisfied for

$$\Phi_n(x) = \frac{1}{n} H(nx \cdot \xi) A,$$

where A is the matrix with rows A_i . It follows that $\|\Phi_n\|_{L^{\infty}(\Omega)} \to 0$ as $n \to \infty$. As a further remark, observe that U_n (and thus also Φ_n) can be taken smooth by means of a mollification of h with a mollification parameter of size asymptotically $1/n^2$.

For $\delta > 0$ let now $\eta_{\delta} \in C_c^{\infty}(\Omega)$ be a cutoff function such that $0 \le \eta_{\delta} \le 1$ and $\eta_{\delta} \equiv 1$ for all $x \in \Omega$ for which $\operatorname{dist}(x, \partial \Omega) > \delta$. Then, by the product rule,

$$\|\eta_{\delta}U_n - \operatorname{curl}(\eta_{\delta}\Phi_n)\|_{L^{\infty}(\Omega)} \le C\|\eta_{\delta}\|_{C^1}\|\Phi_n\|_{L^{\infty}(\Omega)} \le \frac{C}{\delta}\|\Phi_n\|_{L^{\infty}(\Omega)},\tag{4.5}$$

so that by choosing, say, $\delta = \delta(n) = \|\Phi_n\|_{L^{\infty}(\Omega)}^{1/2}$, we can make the left hand side of (4.5) arbitrarily small by choosing n sufficiently large. Thus, choosing $U(x) = \text{curl}(\eta_{\delta(n_0)}\Phi_{n_0})$ for a sufficiently large n_0 , we see that U is as desired: Indeed, i) follows from the fact that U is a curl, the continuity

and boundary values follow by construction, iii) is an immediate consequence of (4.5) and the fact that $\eta_{\delta}U_n$ takes values in K^{2lc} for every $x \in \Omega$; properties ii) and iv) are both implied by the observation that the sequence $(\operatorname{curl}(\eta_{\delta(n)}\Phi_n))_n$ is uniformly bounded in L^{∞} and generates v in the sense of Young measures (cf. e.g. Chapter 3 in [Mül99]).

For the induction step, we use the hypothesis that the Lemma be true for laminates of order n, and consider a laminate ν of order n+1:

$$v = \sum_{i=1}^{n+1} \lambda_i U_i,$$

where $(\lambda_i, U_i)_i$ satisfies the H_{n+1} -condition. Define a laminate of second order by

$$\tilde{\mathbf{v}} = \lambda_{n+1} \delta_{U_{n+1}} + (1 - \lambda_{n+1}) \delta_{\bar{U}}$$

where

$$ar{U} := rac{\sum_{i=1}^n \lambda_i U_i}{\sum_{i=1}^n \lambda_i}.$$

Using Definition 2.3, it is not hard to see that $\operatorname{rank}(U_{n+1} - \bar{U}) \leq 2$ and therefore \tilde{v} is a rank-2 laminate of second order (we omit the conceivable case that $U_{n+1} = \bar{U}$, which is trivial). We may hence find an approximating map \tilde{U} for \tilde{v} with precision ε exactly as in the induction basis (observe that the expectation of \tilde{v} is not necessarily zero, which does not matter for our construction however). By construction, the set

$$S = \left\{ x \in \Omega : \tilde{U}(x) = \bar{U} \right\}$$

is Lipschitz and we may assume that

$$\left|\frac{|S|}{|\Omega|}-\sum_{i=1}^n\lambda_i\right|<\varepsilon.$$

By the induction hypothesis together with Definition 2.3, there exists a map U' on S which approximates the measure

$$\frac{\sum_{i=1}^{n} \lambda_i \delta_{U_i}}{\sum_{i=1}^{n} \lambda_i}$$

with precision ε . Moreover, $U' = \bar{U}$ on the set $\{x \in S : \operatorname{dist}(x, \partial S) < \delta\}$ for some $\delta > 0$. Hence the map defined by

$$U(x) = \begin{cases} U'(x) & \text{if } x \in S \\ \tilde{U}(x) & \text{if } x \in \Omega \setminus S \end{cases}$$

is smooth and satisfies the requirements of the Lemma.

Step 2. As a next step, consider a possibly non-homogeneous measure $(v_x)_x$, whose expectation \bar{v} is however still assumed to be identically zero. This case can be treated as usual by approximating v by a piecewise homogeneous measure and applying Step 1 to each piece. For details see e.g. Section 4.9 in [Mül99]. Observe that, in this step, we may even allow K to depend on $x \in \Omega$ (in a measurable fashion).

Step 3. Let now $(v_x)_x$ be of full generality as assumed in the Lemma. Consider the **shifted** measure μ_x defined by duality via

$$\int_{\mathbb{R}^{d\times d}} h(z)d\mu_{x}(z) = \int_{\mathbb{R}^{d\times d}} h(z-\bar{\mathbf{v}}_{x})d\mathbf{v}_{x}(z)$$

for a.e. $x \in \Omega$ and every test function $h \in C_b(\mathbb{R}^{d \times d})$. Then one sees easily that μ_x is still a rank-2 laminate, and moreover for its expectation $\bar{\mu}_x$ we have

$$\bar{\mu}_x = 0$$
 for a.e. $x \in \Omega$.

Applying Step 2 to μ with K replaced by $K - \bar{v}_x$ (cf. the last observation in Step 2) yields an approximating map W for μ . One can then easily check that

$$U := W + \bar{v}$$

approximates v in the sense of the Lemma.

5. GEOMETRY OF THE NONLINEAR CONSTRAINT

5.1. **Proof of Lemma 3.2.** In this subsection we prove the first geometric lemma, which we recall for the reader's convenience:

Lemma. Let $U \in \mathbb{R}^{3\times 3}$ such that $U^T e_1 = U^T e_2 = 0$ and $|U^T e_3| \ge 1$. Then there exists a rank-2 laminate $v = \sum_{i=1}^n \lambda_i \delta_{U_i}$ such that

$$U = \sum_{i=1}^{n} \lambda_i U_i$$

and a number C > 1 such that

supp
$$\nu$$
 ⊂ K_C .

Moreover there exists a constant C_{β} depending only on β such that $C \leq \max\{C_{\beta}, 4|U^Te_3|\}$.

Proof. Let *U* be as in the statement of the lemma. As usual, we identify it with the triplet (m, v, w) of its row vectors, so by assumption, m = v = 0 and $|w| \ge 1$. We split (0,0,w) into

$$(0,0,w) = \frac{1}{2}(-w,-w,w) + \frac{1}{2}(w,w,w).$$

If we call the matrices correponding to the two triplets on the right hand side U_- and U_+ , respectively, we first observe that U_- and U_+ are rank-2 connected since $(U_- - U_+)e_3 = 0$. Secondly, $U_+ \in K_C$ for any C such that

(recall $\beta(1) = 1$ by Remark 2.2).

Next, let us further decompose U_{-} . We make the ansatz

$$(-w, -w, w) = \frac{1}{2}(\rho_1 v_1, v_1, \beta(\rho_1) v_1) + \frac{1}{2}(\rho_2 v_2, v_2, \beta(\rho_2) v_2)$$
(5.1)

with

$$v_1 = w, \ v_2 = -3w.$$
 (5.2)

Then clearly (5.1) is a rank-2 decomposition (in fact even rank-1), and (5.1) and (5.2) result in the conditions

$$-\rho_1 + 3\rho_2 = 2 -\beta(\rho_1) + 3\beta(\rho_2) = -2.$$
 (5.3)

Let us show that these equations can be satisfied thanks to the strong convexity assumption on β . Indeed, suppose $-\rho_1 + 3\rho_2 = 2$. Then, using Proposition 2.1, we calculate

$$-\beta(\rho_{1}) + 3\beta(\rho_{2}) = 2\left(-\frac{1}{2}\beta(\rho_{1}) + \frac{3}{2}\beta(\rho_{2})\right)$$

$$\leq 2\beta\left(-\frac{1}{2}\rho_{1} + \frac{3}{2}\rho_{2}\right) - 2\kappa\frac{3}{4}|\rho_{1} - \rho_{2}|^{2}$$

$$= 2 - \frac{3}{2}\kappa|\rho_{1} - \rho_{2}|^{2}.$$
(5.4)

Finally, the equation $-\rho_1 + 3\rho_2 = 2$ can be rewritten as $\rho_1 - \rho_2 = 2\rho_2 - 2$, and therefore by (5.4) we can achieve (5.3) by choosing $\rho_2 > 1$ sufficiently large and then setting $\rho_1 = 3\rho_2 - 2 > 1$.

Since, with this choice of ρ_1, ρ_2 , the triplets $(\rho_1 v_1, v_1, \beta(\rho_1) v_1)$ and $(\rho_2 v_2, v_2, \beta(\rho_2) v_2)$ are in K_C for a suitable C, the proof is finished. In particular, the estimate for C in the statement of the lemma follows directly from our construction.

5.2. **Proof of Lemma 3.3.** Recall Lemma 3.3:

Lemma. Let $\varepsilon > 0$ and $\tilde{C} > 1$. There exists a strictly increasing continuous function $h : [0, \infty) \to [0, \infty)$, depending only on \tilde{C} and β , with h(0) = 0, and a number $\delta > 0$, depending only on \tilde{C} , β , and ε , such that for every $1 < C < \tilde{C} - \varepsilon$ and every $U \in \mathbb{R}^{3 \times 3}$ such that $\operatorname{dist}(U, K_C^{2lc}) < \delta$, there exists a rank-2 laminate $v = \sum_{i=1}^n \lambda_i \delta_{U_i}$ such that

$$U = \sum_{i=1}^{n} \lambda_i U_i, \tag{5.5}$$

$$\sum_{i=1}^{n} \lambda_i |U_i - U| \le h\left(\operatorname{dist}(U, K_C)\right),\tag{5.6}$$

and

$$\operatorname{supp} V \subset K_{C+\varepsilon}. \tag{5.7}$$

Proof. As usual we denote by (m, v, w) the rows of the matrix U. We proceed in five steps:

Step 1. Suppose the vectors (m, v, w) are collinear, so that there exist real numbers α , γ such that $m = \alpha v$ and $w = \gamma v$. Note that if δ' is sufficiently small, then $\operatorname{dist}(U, K_C) < \delta'$ implies

$$\frac{1}{C+\varepsilon} < |\nu| < C+\varepsilon. \tag{5.8}$$

Note that the meaning of "sufficiently small" here can be understood to depend only on ε and \tilde{C} . We want to find a decomposition using the ansatz

$$(m, v, w) = \lambda(m_1, v_1, w_1) + (1 - \lambda)(m_2, v_2, w_2),$$

where $v_1 = \tau_1 v$ and $v_2 = \tau_2 v$. Clearly, this defines a rank-2 (even rank-1) decomposition regardless of the values of λ , τ_1 and τ_2 . The requirement that (m_1, v_1, w_1) and (m_2, v_2, w_2) lie in the set $K_{C+\varepsilon}$ then leads to the requirement that there exist $\rho_1, \rho_2 > 0$ such that

$$\lambda \tau_1 + (1 - \lambda)\tau_2 = 1$$

$$\lambda \tau_1 \rho_1 + (1 - \lambda)\tau_2 \rho_2 = \alpha$$

$$\lambda \tau_1 \beta(\rho_1) + (1 - \lambda)\tau_2 \beta(\rho_2) = \gamma.$$
(5.9)

If it happens that $\gamma = \beta(\alpha) + \eta$ for some $\eta \ge 0$, we set $\tau_1 = \tau_2 = 1$ so that the first equation of (5.9) is automatically satisfied and the other two equations become

$$\lambda \rho_1 + (1 - \lambda)\rho_2 = \alpha$$

$$\lambda \beta(\rho_1) + (1 - \lambda)\beta(\rho_2) = \beta(\alpha) + \eta.$$
 (5.10)

By the first of these equations and the strong convexity of β , we have

$$\lambda \beta(\rho_1) + (1-\lambda)\beta(\rho_2) \ge \beta(\alpha) + \kappa \lambda (1-\lambda)|\rho_1 - \rho_2|^2$$
.

Therefore, it is possible to find functions $\lambda(\eta)$, $\rho_1(\eta)$, and $\rho_2(\eta)$, depending on β and α , that are continuous in η and satisfy $\lambda(0) = 1$, $\rho_1(0) = \rho_2(0) = \alpha$ such that (5.10) is satisfied for every $\eta \geq 0$. Since, if $\operatorname{dist}(U, K_C) < \delta'$, we can make η arbitrarily small by choosing δ' sufficiently small (depending only on \tilde{C} , β , and η), we can ensure

$$\frac{1}{C+\varepsilon} < \rho_1, \rho_2 < C+\varepsilon$$

for δ' small enough. Together with (5.8) we conclude that

$$(m_1, v_1, w_1), (m_2, v_2, w_2) \in K_{C+\varepsilon}.$$

Thus we have established (5.5) and (5.7).

Next, suppose $\gamma = \beta(\alpha) - \eta$ for some $\eta > 0$. Then, in (5.9) we choose $\tau_1 = (2 - \lambda)/\lambda$ and $\tau_2 = -1$ to eliminate the first equation and arrive at

$$\lambda \tau_1 \rho_1 - (1 - \lambda) \rho_2 = \alpha$$

$$\lambda \tau_1 \beta(\rho_1) - (1 - \lambda) \beta(\rho_2) = \beta(\alpha) - \eta.$$
(5.11)

Then, by Proposition 2.1 (replacing λ by $-(1-\lambda)$, x_1 by ρ_2 and x_2 by ρ_1 and keeping in mind $\lambda \tau_1 - (1-\lambda) = 1$), we have

$$\lambda \tau_1 \beta(\rho_1) - (1 - \lambda) \beta(\rho_2) \le \beta(\alpha) - \kappa(2 - \lambda)(1 - \lambda)|\rho_1 - \rho_2|^2.$$

Assertions (5.5) and (5.7) then follow by the same arguments as above, observing that again $\eta = 0$ corresponds to $\lambda = 1$, $\rho_1 = \rho_2 = \alpha$. This completes Step 1.

Notice again that $\delta' > 0$ constructed in Step 1 depends on ε , β , and \tilde{C} , but not on U, or C.

Step 2. Suppose now that m and v are parallel, that is, there exists a real number α such that $m = \alpha v$. (We are no longer assuming that w be parallel with m and v.) Again, we wish to represent (m, v, w) as a rank-2 combination of two triplets,

$$(m, v, w) = \lambda(m_1, v_1, w_1) + (1 - \lambda)(m_2, v_2, w_2),$$

where m_i , v_i , w_i are collinear (i = 1, 2), so that we can proceed as in Step 1. To this end, take the ansatz $m_i = \alpha v_i$, $w_i = \mu_i v_i$, and set $\lambda = 1/2$:

$$v_1 + v_2 = 2v$$

$$\alpha v_1 + \alpha v_2 = 2\alpha v$$

$$\mu_1 v_1 + \mu_2 v_2 = 2w.$$
(5.12)

First, clearly $(m_2, v_2, w_2) - (m_1, v_1, w_1)$ has rank at most 2 with this ansatz. Secondly, if v_1 and v_2 are chosen linearly independent and in the plane spanned by v and w, then they form a basis of this subspace and therefore (5.12) can be solved (if w and v are already parallel, it can be trivially solved). More specifically, if $\eta > 0$, then by choosing $\delta'' > 0$ small enough (depending only on \tilde{C} , β , and η) we can ensure that $\operatorname{dist}(U, K_C) < \delta''$ implies $|w - \beta(\alpha)v| < \eta$. When $w = \beta(\alpha)v$ exactly, we can simply set $v_1 = v_2 = v$ and $\mu_1 = \mu_2 = \beta(\alpha)$. Therefore, there exist continuous maps $v_i(w)$, $\mu_i(w)$ (i = 1, 2) depending on α , β such that $v_i(\beta(\alpha)v) = v$ and $\mu_i(\beta(\alpha)v) = \beta(\alpha)$

and such that (5.12) is satisfied for any w. It follows that, by choosing $\delta'' > 0$ sufficiently small, $\operatorname{dist}(U, K_C) < \delta''$ guarantees

$$dist((m_i, v_i, w_i), K_C) < \delta' \ (i = 1, 2)$$

for the number δ' established in Step 1. We may therefore decompose each (m_i, v_i, w_i) further as in Step 1, which yields a rank-2 decomposition of (m, v, w) into (at most) four triplets in $K_{C+\varepsilon}$, each satisfying (5.5), (5.6). Note again that δ'' depends only on \tilde{C} , β , and ε .

Step 3. Consider now a general triplet (m, v, w). We want to decompose (m, v, w) into two triplets along rank-2 lines,

$$(m, v, w) = \lambda(m_1, v_1, w_1) + (1 - \lambda)(m_2, v_2, w_2),$$

such that there exist α_1, α_2 such that $m_1 = \alpha_1 v_1$, $m_2 = \alpha_2 v_2$, so that Step 2 can be applied to both (m_i, v_i, w_i) individually. We take the ansatz $\lambda = 1/2$, $w_1 = w_2 = w$ (thereby ensuring our decomposition runs along a rank-2 line), to obtain the equations

$$v_1 + v_2 = 2v$$
$$\alpha_1 v_1 + \alpha_2 v_2 = 2m.$$

The exact same reasoning as in Step 2 then yields a $\delta > 0$ depending only on \tilde{C} , β , and ε such that $\operatorname{dist}((m, v, w), K_C) < \delta$ ensures that

$$dist((m_i, v_i, w_i), K_C) < \delta'' \ (i = 1, 2),$$

where δ'' is the number from Step 2.

Step 4. So far we have produced $\delta > 0$ such that the assertions of Lemma 3.3 are true provided $\operatorname{dist}(U, K_C) < \delta$. Let now U be such that only

$$\operatorname{dist}(U, K_C^{2lc}) < \delta$$
.

By assumption and the definition of the rank-2 lamination convex hull (Definition 2.4), U can be written as

$$U = \sum_{i=1}^{n} \lambda_i U_i + \tilde{U} = \sum_{i=1}^{n} \lambda_i (U_i + \tilde{U}),$$

where $|\tilde{U}| < \delta$, the family (λ_i, U_i) satisfies the H_n -condition, and $U_i \in K_C$ (i = 1...n). But for every i, we can now apply Steps 1–3 to $U_i + \tilde{U}$, which completes the proof of Lemma 3.3 modulo the estimate (5.6).

Step 5. It remains to exhibit a function h that renders (5.6) correct. To this end, recall that the λ_i and U_i which we constructed in the previous steps depended solely on U and β , so that in particular the left hand side of (5.6) is independent of C. Moreover, if $U \in K_{\tilde{C}}$, our construction leaves U unchanged, so that the left hand side of (5.6), considered as a function of U (with β fixed), is zero on $K_{\tilde{C}}$. The last observation needed is that, by construction, the left hand side $\sum_{i=1}^{n} \lambda_i |U_i - U|$ depends on U continuously in a δ -neighborhood of $K_{\tilde{C}}^{2lc}$.

The distance function $\operatorname{dist}(U, K_{\tilde{C}})$ is of course zero on $K_{\tilde{C}}$ and positive elsewhere (since $K_{\tilde{C}}$ is compact). Therefore, we may define

$$h(t) = \max_{\mathcal{U}_t} \left\{ \sum_{i=1}^n \lambda_i |U_i - U| \right\},$$

where we set $\mathcal{U}_t = \{U \in \mathbb{R}^{3\times 3} : \operatorname{dist}(U, K_{\tilde{C}}) = t\}$. Again we considered the left hand side of (5.6) as a continuous function of U. We may further assume h to be strictly increasing by choosing it larger if necessary.

Then, by definition of h we have

$$\sum_{i=1}^{n} \lambda_{i} |U_{i} - U| \le h\left(\operatorname{dist}(U, K_{\tilde{C}})\right) \le h\left(\operatorname{dist}(U, K_{C})\right)$$

for any $C \leq \tilde{C}$, since then $K_{C_1} \subset K_{\tilde{C}}$. The proof is thus complete.
